AWARDS: Juror of Awards to be Announced. Awards to include \$250 Best of Show award, as well as Artists' Choice and Collectors' Choice Awards and Pastel Society of New Mexico Award.

GENERAL REQUIREMENTS:

Open to **first 50** PAPNM members who register and pay entry fee, without regard to artist's geographic location.

- Each participating artist will be allowed to enter two (2) paintings.
- All work must be at least 80% completed *en plein air*, within the allotted Paintout period and within the specified Paintout locations.
- All work must be for sale. Artists receive 50% of the sale price. Wilder Nightingale Fine Art retains 40% and PAPNM receives 10%. The gallery is authorized to give, at its discretion, a 10% discount (split between the gallery 5% and the artist 5%).

FRAMING REQUIREMENTS:

16" x 20" is maximum outside framed dimension (320 square inches maximum including the frame). Accepted work must be sturdily framed and ready to hang, with D-rings and wire. No sawtooth hangers will be accepted.

ENTRY FEE: \$60.00 (Non-refundable)

AGREEMENT OF ENTRY & LIABILITY:

All reasonable care will be taken with paintings. However, neither Wilder Nightingale Fine Art, nor Plein Air Painters of New Mexico, their agents, employees, volunteers or anyone working on the exhibition will be held responsible for any loss or damage to artworks left in the gallery. Insurance is the responsibility of the artist.

- PAPNM reserves the right to reproduce accepted artwork for publicity purposes.
- PAPNM reserves the right to reject work deemed unsuitable for public viewing.
- **Your entry and payment constitute acceptance of all conditions and terms in this prospectus.**

DELIVERY: Thursday, July 30

Hand-deliver framed paintings to Wilder Nightingale Fine Art, starting at 10 am and **no later than 5 pm.**

RETRIEVAL: Sunday, August 16 from 4-5 pm, or Monday, August 17 from 10 am to 5 pm.

- All unsold paintings **must** be picked up from Wilder Nightingale Fine Art by the artist, or a designated representative, no later than 5 pm.
- To have paintings returned by a delivery service, prepaid shipping documents and carton(s) must be supplied when paintings are delivered to the show. If you use a wooden crate, it must be sealed with screws only (not nailed). A very sturdy professional corrugated box, with full interior packing, is acceptable. Generally, 2" of packing material around all edges is desirable. Do **not** use Styrofoam peanuts as packing material.
- Cost of shipping painting(s) and any shipping insurance is the responsibility of the artist.
- Any unclaimed paintings will become the property of PAPNM and will be disposed of as the Board sees fit.

PRESENTATION REQUIREMENTS:

Biography: Please provide a short (one side of a standard 8.5" x 11" sheet) typewritten biographical statement, which the gallery

will keep on file for collectors who request information about you as an artist. These will be collected at receiving.

Digital Images: A list of participating artists and images of their paintings, medium, size, and price will be posted on Wilder Nightingale Fine Art's web site. If you have the capability to provide digital images of your paintings we encourage you to do so. Otherwise we will take digital photos of your paintings when they are delivered to the gallery.

Digital images must meet the following requirements:

Format: JPG format, 72DPI, 500 to 1500 pixels wide. Include your last name and the title of the painting in the file name.

Submission may be on CD or as an Email Attachment:

CD Submission: Submitted to the gallery at check-in. Label CDs with your name, painting title, painting medium, painting size, painting price and the letters PAPNM. *CDs will not be returned to the artist.*

Email Submission: Send attached JPG files to info@wnightingale.com

Subject line should read "PAPNM PAINTING". In the message area of your email, include the painting title, painting medium, painting size, painting price and your name. Deadline for emailed files is 5PM Thursday, July 30, 2009.
